This project consists of approximately 150,750 SF of renovations, and approximately 13,980 SF additions, at Waynesboro High School, along with related asbestos abatement. All bids shall be on a lump sum basis.

2. Bids shall be received until 2:00 P.M. local prevailing time on June 28, 2018, to the attention of Dr. Jeffrey Cassell, Superintendent, Waynesboro Public Schools, 301 Pine Avenue, Waynesboro, VA 22980 at which time bids will be opened publicly and read aloud. Bids received after this time will not be accepted. All interested parties are invited to attend.

4. Plans and specifications can be obtained via download from ShareFile upon receipt of a nonrefundable check in the amount of \$50.00. Upon receipt of check and valid email address, OWPR will provide a password with instructions on accessing and downloading plans and specifications. Hard copies of plans and specifications can be obtained from OWPR upon receipt of a nonrefundable check in the amount of \$500.00. Plans and specifications can be shipped for additional charge. Contact OWPR for further details.

5. Bids shall be accompanied by a bid guarantee of not less than 5% of the amount of the bid, which may be a certified check or cashier's check, or a bid bond of 5% of the amount of the bid, made payable to Waynesboro School Board. A performance bond, payment bond and a material and labor bond will be required and the cost shall be included in the bid price.

6. Bidders are required under Title 54.1, Chapter 11, Code of Virginia (1950), as amended, to be licensed as a "Class A Contractor" before submitting a bid of one hundred twenty thousand (\$120,000) dollars or more; or to be licensed as a "Class B Contractor" before submitting a bid of ten thousand (\$10,000) dollars or more but less than one hundred twenty thousand (\$120,000) dollars; or be licensed as a "Class C Contractor" before submitting a bid of no more than ten thousand dollars (\$10,000). Each Bidder will be required to give their State Registration Number on their proposal. All non-resident contractors and subcontractors bidding the work described herein shall register with the Department of Labor and Industry under the provisions of Section 40.1-30 of the Code of Virginia.

7. The Owner reserves the right to waive irregularities and to reject any or all bids.

a. A pre-bid conference will be held on June 12, 2018 beginning at 2:00 P.M. at Waynesboro High School Auditorium located at 1200 West Main Street, Waynesboro, VA 22980. This will provide an opportunity to answer questions and explain any items requiring further clarification.

8. Bids shall be binding for a period of sixty (60) days from the date on which bids are opened.
